- 1. WE HAVE BEEN DISCOURAGING REQUESTS FROM TV REPORTERS HERE WHO HAVE ASKED ABOUT THE POSSIBILITY OF POST-ELECTION INTERVIEWS WITH US OFFICIALS TO ELICIT REACTIONS TO THE ELECTION RESULTS. WE RECOMMEND THAT WASHINGTON AGENCIES FOLLOW SUIT.
- 2. ELEMENTS OF THE MEDIA WOULD NOT BE ADVERSE TO QUOTING WASHINGTON COMMENTS IN A CONTEXT WHICH COULD MAKE THEM EMBARRASSING TO MRS. THATCHER.
- 3. IN OUR VIEW, US COMMENT ON THE RESULTS OF THE BRITISH ELECTIONS SHOULD COME FROM THE WHITE HOUSE EXCLUSIVELY, AND FOCUS ON THE FACT THAT WE LOOK FORWARD TO CONTINUING THE CLOSE WORKING RELATIONSHIP WE HAVE CONFIDENTIAL
