SUMMARY

- 1. GROMYKO SAHD NOTHING NEW ON THE SUBSTANCE OF THE HE KEPT COMPLAINTING ABOUT THE WESTERN MINSHSTANCE ON AMERICAN STATIONING AND REFUSAL TO COUNT BRITISH AND FRENCH SYSTEMS. REGARDING THE FUTURE OF THE GENEVA NEGOTIMATONS, HE SAND THAT THE SOVIET UNHON WAS CONSHDERING WHAT WOULD HAPPEN IF THE DOUBLE DECISION WAS CARRIED OUT AND STATIONING BEGAN
- 2. GENSCHER AND GROMYKO REACHED AGREEMENT ON BALATERAL MEETINGS OF OFFICINALS ON VARIAUS SUBJECTS. THE GERMANS HOPE THAT THIS HIS AN HANDINGATION THAT EAST—WEST CONTACTS CAN CONTINUE AFTER STATIONING STARTS.

## REPORT

- 3. RUTH (UNDER SECRETARY FOR ARMS CONTROL) AND VON BRAUNMUEHL (UNDER SECRETARY FOR WARSAW PACT COUNTRIES) OF THE AUSWAERTINGES AMT BRE-IFED AMBASSADORS OF THE TEN THIS EVENING ABOUT THE GENSCHER/ GROMYKO TALKS.
- THREE MAIN SUBJECTS WERE DISCUSSED: ARMS CONTROL ESPECIALLY HAF, EAST-WEST RELATIONS AND BENLATERAL RELATIONS. THE LAST TWO ARE COVERED HAN MIFT.
- ON MANE, GENSCHER MADE THREE MAJOR POINTS. THE MATERIAL NOT THE WHOLE OF THE ARMS CONTROL AGENDA, ALTHOUGH AN IMPORTANT PART OF MT. THE WESTERN NEGOTIATION POSITION WAS NOT A UNILATERAL US POSITION BUT ONE DRAWN UP BY NATO AND FULLY SUPPORTED BY THE FRG (GENSCHER'S AMM HERE WAS TO FORESTALL ANY EFFORTS TO ISOLATE THE US AS THE CULPRITS OF THE GENEVA TALKS BREAK DOWN). NATO WOULD CONTINUE TO UPHOLD BOTH PARTS OF THE DOUBLE DECISION OF THERE WAS NO NEGOTIATION RESULT THIS YEAR, STATIONING WOULD TAKE PLACE ON TIME. BUT MY WOULD NOT BE PRREVERSIBLE AND NEGOTIATIONS SHOULD CONTINUE.

6. GROMYKO SAND THAT THE SOVIET VIEW OF THE NEGOTIATIONS WAS PESSAMISTIC. THE WEST WAS TO BLAME DIT WAS NOT WILLIAMS TO CONSIDER ARRANGEMENTS THAT DID NOT HAVOLVE US STATHONING AND WAS REFUSING TO TAKE ACCOUNT OF BRITISH AND FRENCH SYSTEMS.

REAGAN, S RECENT PROPOSALS DID NOT ADDRESS THESE POINTS AND COULD NOT ADVANCE THE NEGOTIATIONS. GENSCHER RECEIVED THE IMPRESSION THAT GROMYKO UNDER-ESTIMATED THE SIGNIFICANCE OF REAGAN, S MOVES, AND EXPLAINED THEM INDETAIL TO HIM. GROMYKO SAND THAT THE SOVIET

UNION WAS AT PRESENT CONTINUING THE GENEVA NEGOTIMATIONS AND CONSIDERING IN PARALLEL WHAT SHOULD HAPPEN IN THE DOUBLE DECISION WAS CARRIED OUT AND STATIONING BEGAN. HE GROMYKO MADE CLEAR THAT THIS MEANT THE SOVIET UNION HAD NOT DECIDED WHETHER TO CONTINUE NEGOTIMATIONS. HIS REFERENCES TO WARSAW PACTCOUNTER MEASURES FOLLOWING WESTERN STATIONING WERE VERY BRIEF AND TO THE EFFECT THAT THE MEMBERS OF THE PACT WOULD DO WHAT WAS NECESSARY FOR THEIR SECURITY. GROMYKO MADE NO THREAT ABOUT CUTTING OFF OTHER ARMS CONTROL NEGOTIMATIONS.

- THERE WAS CONSIDERABLE DISCUSSION BETWEEN GENSCHER AND GROMYKO ABOUT WHAT COSTITUTES A STRATEGIC WEAPON. GROMYKO SAIND THAT, FOR THE SOVINET UNION, PERSHANG 2 AND CRUISE WERE OF STRATEGIC SUGNIFICANCE BECAUSE THEY COULD REACH SOVINET TERRITORY, WHEREAS SOVINET WINTERMEDITATE—RANGE MISSILES WHICH COULD NOT REACH US TERRITORY WERE NOT STRATEGIC BECAUSE THEY COULD NOT THREATEN THE OTHER SUPER—POWER. GENSCHER IN REPLY SAIND THAT THE SS2D POSED A STRATEGIC THREAT TO THE FRG, WHICH WAS WHY THE LATTER, A STATE WHICH HAD UNDERTAKEN NOT TO OWN NUCLEAR WEAPONS, MUST SEEK US SUPPORT.
- 8. COMMENTING ON THE ABOVE, RUTH SAND THAT GROMYKO HAD SHOWN NO FLEX-HB-ILLITY AND HAD NOT MENDIFICATED THAT ANY NEW SOVIET PROPOSALS WERE HAN PREPARATHON. BUT HAT HAD BEEN USEFUL TO HEAR SOVIET VINEWS FROM GROMYKO HUMSELF AND TO MAKE SURETHAT THE SOVIET UNHON AT THUS LEVELKNEW AND HAD FULL AND CLEAR KNOWLEDGE OF THE WESTERN POSHITHON. GROMYKO WAS NOW VILSHITHING EAST BERLIN, WHERE HE MINGHT SAY HAN PUBLIC SOME OF THE THINGS HE HAD SAND TO GENSCHER.
