SECRETARY OF STATE'S BHLATERAL WITH SHEVARDNADZE, 23 SEPTEMBER

#### SUMMARY

1. A BUSHNESSLIKE DISCUSSION WHICH COVERED A LOT OF GROUND IN ONE HOUR. SHEVARDNADZE DETERMINEDLY GENHAL AND FULLY ON TOP OF THE SUBJECTS. NO NEW HINSINGHT WINTO DANHLOFF OR PROSPECTS FOR SUMMIT.

- 2. SHEVARDNADZE RECALLED HAS USEFUL JULY VANSET TO BRATAMA, ON WHACH HE HAD REPORTED FULLY TO GORBACHEV. FAT WAS GOOD THAT AGREEMENT HAD BEEN REACHED ON THE PRAME MANNISTER'S WASHIT TO MOSCOW NEXT SPRANG. THE SECRETARY OF STATE AGREED, ADDING THAT MR RENTON ALSO HOPED TO WASHIT THE SOVERET UNKNON EARLY AND 1987. THE SECRETARY OF STATE ALSO NOTED THE FORTHCOMANG SUPREME SOVERET VANSET TO BRATAMA, AND UNDERLAND THE AMPORTANCE OF BALATERAL TALKS BETWEEN EXPERTS ABOUT ARMS CONTROL, MOST RECENTLY ON CHEMICAL WEAPONS. WE LOOKED FORWARD TO EXPERT TALKS ON TERRORISM.
- 3. THE SECRETARY OF STATE RANSED THE PROBLEM OF VASA APPLICATIONS
  FOR UNACCEPTABLE APPOINTMENTS TO THE SOURCE EMBASSY AND TRADE

  DELEGATION IN LONDON. WE MATCHED OUR FIRM COMMITMENT TO SAFEGUARDING
  OUR SECURIATY WHITH A SHINCERE WISH FOR IMPROVED RELATIONS. CANDIDLY,
  SOME OF THOSE NOW BEING PROPOSED DID NOT MEET OUR CRITERIA AND HE
  HOPED SHEVARDNADZE WOULD ASK HAS PEOPLE TO LOOK AGAIN AT THOSE
  PROBLEM CASES. SHEVARDNADZE DID NOT RESPOND UNTIL LATER IN THE
  DISCUSSION, WHEN HE SAND THAT HE WAS NOT AWARE OF ANY DIMFFRICULTY.

  (HE SEEMED AT FIRST TO MISUNDERSTAND, THANKING THAT OUR OBJECTION
  WAS TO PEOPLE ALREADY SERVING IN LONDON, BUT THE SECRETARY OF
  STATE CLARIFINED THIS). HE WE HAD DATA ABOUT SPECIATION NEW APPLICANTS,
  THEN WE SHOULD GIVE INT TO THE RUSSIANS. THE SECRETARY OF STATE
  REPEATED HIS HOPE THAT THES WOULD NOT BE ALLOWED TO BECOME AN
  HIMPEDIMMENT TO THE DEVELOPMENT OF AMPROVED BILLATERAL RELATIONS, AND
  ADDED THAT PEOPLE FROM THE MFA WERE USUALLY ACCEPTABLE.

4. SHEVARDNADZE RECALLED DISCUSSION OF CDE IN LONDON IN JULY. SINCE
THEN JOINT EFFORTS HAD LED TO A MAJOR POLITICAL SUCCESS, THE
RESULTS OF WHICH WOULD BE FELT BY ALL NATIONS. THE RUSSIANS WERE
VERY SATISFIED, AND WOULD NOT NOW WISH TO DISPUTE WITH US WHO SHOULD
TAKE THE CREDIT FOR THE OUTCOME. THE SECRETARY OF STATE NOTED THE
SHAPILARITY OF HAS AND SHEVARDNADZE'S REMARKS ON THIS SUBJECT TO
THE UNGA.

5. SHEVARDNADZE SAND THAT GOOD GROUND-WORK HAD ALSO BEEN LAND FOR VHENNA. ON CHEMICAL WEAPONS, THERE WAS A REAL-MST-C POSSIBILINTY OF CONCLUDING AN INTERNATIONAL CONVENTION NEXT YEAR. DIFFICULT QUESTIONS REMAINED, MINCLUDING MINSPECTMONS, BUT THE BRITISH PROPOSAL ON CHALLENGE MINSPECTMONS CONTAINED MANY ELEMENTS WORTHY OF CONSIDERATION, AND COULD BE THE BASMS OF A SOLUTION. HE HAD SAND THE SAME TO SHULTZ.

6. HAN REPLY THE SECRETARY OF STATE OBSERVED THAT EACH OF THE THREE CSCE BASKETS WAS HAMPORTANT. REACHING AGREEMENT ON ARMS CONTROL WAS AS HAMPORTANT FOR THOSE RESPONSIBLE FOR THEMR COUNTRY'S DEFENCE AS HAT WAS FOR THOSE DEALING SPECIFICALLY WHITH ARMS CONTROL. NEITHER SHIDE'S MILLITARY COULD GUARANTEE SECURITY UNLESS THERE WERE SOME LIMINTS ON THE RESOURCES WHICH THE OTHER SHIDE WERE ABLE TO DEDICATE TO DEFENCE.

#### TESTING

CSCE

7. SHEVARDNADZE HOPED THAT COMMON GROUND MANGHT ALSO BE REACHED ON A TEST BAN. MOST STATES FAVOURED THAS, ALTHOUGH HE KNEW THE BRANTASH AND AMERICAN OBJECTIONS. THERE WAS NOW NO TECHNOCAL PROBLEM ABOUT VERNEYUNG A CESSATION OF TESTING: BRANTASH SHOULD REFLECT FURTHER ABOUT THAS. THE RUSSIANS WERE CONTENT TO RESUME TRALATERAL OR BALATERAL TALKS WHENEVER WE WASHED. THE SECRETARY OF STATE REPLIED THAT THE VERNEFICATION PROBLEM WAS A GENUSINE ONES AS THE TAME SPENT ON THIS WISSUE AT STOCKHOLM AND FAN THE CHEMICAL WEAPONS CONTEXT DEMONSTRATED. SHEVARDNADZE ARGUED THAT THESE CASES WERE DAFFERENT, AND RECALLED THE REFERENCE FAN HAS UNGA SPEECH TO THE PRESENCE OF AMERICAN SCHENTISTS AT SEMEPALATIONSK. THE THRESHOLD WAS OPEN TO DASCUSSMON BUT THE NON-EXPISTENCE OF TESTS WAS STRANGHTFORWARD TO VERMEY. THE SECRETARY OF STATE REPLIED THAT A STEP BY STEP APPROACH WAS BESTS STARTING WINTH RATIFFICATION OF PNET AND TIBT.

#### TERRORISM

8. SHEVARDNADZE SAND THAT BRIETHISH AND SOVMET APPROACHES WERE SHAMELAR AND HE HAD NO OBJECTHON TO BELATERAL MEETHINGS BETWEEN EXPERTS TO DISCUSS PRACTICAL MEASURES. INT WAS IMPORTANT TO AVOID UNSUBSTANTMATED ACCUSATIONS AGAINST HINDINVIDUAL STATES OR GROUPS. EVADENCE WAS REQUIRED AND HE HAD SAND THUS TO SHULTZ. HE HELD NO BRHEF FOR GADHAFIN, BUT NOTED THAT GADHAFIN HAD OFFERED AT HARARE TO SUBMET TO TRETAL FOR ALLEGED LIBYAN MINVOLVEMENT IN TERRORMSM. AS FOR PREVENT-INE MEASURES, THE RUSSMANS WOULD COOPERATE HE SPECHENC CHIFORMATSHON WERE MADE AVAILABLE. THE SECRETARY OF STATE UNDERLINED THE SERVIOUSNESS OF STATE-SPONSORED TERRORASM: WE HAN BRESTAIN HAD HAD EXPERSENCE OF THE LIBYAN VARISETY. HET WAS RIGHT TO AVOID HASTY ACCUSATIONS, BUT WE HAD GOOD EVEDENCE OF LINBYA SUPPLYING THE HARA WITH WEAPONS. AND GADHAFIN WAS PUBLICLY COMMITTED TO SUPPORTING WARMSH TERRORISM. SHEVARDNADZE RETREATED WATO A COMPARASON BETWEEN GADHAFIR'S SUPPORT OF THE HARA AND AMERICAN POLICHES TOWARDS NICARAGUA AND ANGOLATIAL 2 EAST 9. THE SECRETARY OF STATE STRESSED THAT WHILE PROGRESS BEGAN TO LOOK POSSIBBLE ON THE ARMS CONTROL AGENDA, THE DANIELOFF CASE HOWEVER CREATED A DAFFMCULTY WHACH THE RUSSMANS SHOULD REMOVE. HIT MUST NOT BE ALLOWED TO MMPEDE THAT PROGRESS. SHEVARDNADZE REPLIED THAT WE EVENDENTLY DOLD NOT KNOW THE DETANLS OF THE CASE. WE SHOULD HAVE ASKED HIM ABOUT HIT RATHER THAN AUTOMATICALLY BELIEVING THE AMERICAN VERSION. EVIDENCE WOULD BE PRODUCED AT DANHLOFF'S TRIBAL, AND HE WOULD BE CONVECTED ACCORDING TO SOVEET LAW. THE TWELVE WOULD THEN REGRET THEMR DEMARCHE. WHY DAND WE MMAGINE THE RUSSMANS WOULD HAVE BEGUN SUCH PROCEEDANGS, HF THEY LACKED ADEQUATE EVADENCE? THE SECRETARY OF STATE SPOKE FHRMLY IN REPLY REFUSING TO BE DRAWN ON TO THEIS TERRALINE, BUT BRITINGING OUT DANHLOFF'S BACKGROUND AND THE FACT THAT MRS DANILOFF WAS BRUTHSH. SHEVARDNADZE SAND THAT THE ZAKHAROV CASE HAD BEEN A SET UP. INT HAD BEEN A SERHOUS MISTAKE FOR PRESMIDENT REAGAN TO RAMSE THESE MISSUES AND HAIS UNGA SPEECH, WHEN NEGOTHATHONS WERE TAKHING PLACE WHTH THE AMERICANS ABOUT THEM. THE RUSSMANS HAD PROPOSED TWO OR THREE POSSMBLE SOLUTMONS, BUT REAGAN WAS MORE MINTERESTED IN PROPAGANDA. SHEVARDNADZE WOULD NOT USE THE GENERAL ASSEMBLY TO REBUT AMERICAN ACCUSATIONS, BUT HAD INSTEAD MET SHULTZ AGAMN ON 23 SEPTEMBER TO DUSCUSS THE MATTER PRHIVATELY. HE HOPED WE WOULD URGE THE AMERICANS TO REMOVE THESE HIMPEDIAMENTS TO A SUMMIT. THE SECRETARY OF STATE SAND THE WHOLE WORLD WISHED THE AMERICANS AND RUSSMANS NOT TO LET PROGRESS TOWARDS A SUMMENT BE STALEMATED BY THESE DEFFICULTHES.

10. SHEVARDNADZE REFERRED TO THE EXPULSION OF THE 25 SOVET DEPLOMATS FROM THE UN. HE FOUND THE THINKING, ONE DAY BEFORE HAS ARRESTALL, EXPLICABLE ONLY AS AN ATTEMPT BY ANTI-SOVIET ELEMENTS OF AMERICA TO THWART AN IMPROVEMENT ON BHILATERAL RELATIONS. THE AMERICANS KNEW THAT THE RUSSIONS RESPONDED ON KOOD TO SUCH EXPULSIONS. THE SECRETARY OF STATE NOTED THAT SUMMLAR QUESTIONS ABOUT THINKING HAD BEEN RANSED ON RELATION TO DANISLOFF.

#### HUMAN RINGHTS

11. THE SECRETARY OF STATE RECALLED HAS PREVAOUS DESCUSSIONS WHITH SHEVARDNADZE OVER HUMAN RENGHTS CASES, ENCLUDING MERCHA RATUSHINISKAYA (ABOUT WHOM THERE WAS A PREDECTABLE EXCHANGE).

ANOTHER CATEGORY OF EMPORTANCE WAS PERSONAL REUNIHON AND FAMILY CASES, ENCLUDING LAPTEV. HE HANDED OVER A BOUT DE PAPIER SETTING OUT THE FACTS OF THE CASE (TEXT FOLLOWS BY MUFAX TO FCO) MAKING THE POINT THAT HIT WAS HARD TO SEE WHY LAPTEV COULD NOT BE ALLOWED OUT TO JOHN HIS WAFE. HIT WOULD BE BETTER FOR THE RUSSMANS TO AGREE THIS NOW, AND AVOID A PUBLIC CAMPAIGN BY LAPTEV'S WAFE.

SHEVARDNADZE ACCEPTED THE PRECE OF PAPER AND WROTE ON INT AN INSTRUCTION THAT A REPLY BE PRODUCED.

12. THE SECRETARY OF STATE SAND THAT ALTHOUGH WE HAD NOT SEEN AN OFFICIAL COPY OF THE SOVIET/ARGENTHINE AGREEMENT, HITS TEXT SEEMED TO INCLUDE FALKLANDS WATERS!, WHICH WOULD MAKE IT UNACCEPTABLE TO US. SHEVARDNADZE STUDHED HIS BRHEF VERY CAREFULLY AND THEN SAND THAT SOVINET AGENCIES HAD ASSURED HIM THAT THE AGREEMENT WOULD NOT AFFECT LEGINTUMATE BRIGITIASH MINTERESTS AND WAS IN AGREEMENT WITH MATERNATIONAL LAW. THERE WAS THEREFORE NO REASON FOR BRHITAMIN TO BE CONCERNED. AS FOR TRANSMITTIENG THE TEXT TO USE, THEIS COULD NOT BE DONE UNTIL HIST WAS PUBLISHED, AND ONLY WHITH THE AGREEMENT OF ARGENTAINA. HE HAD LOOKED CAREFULLY HINTO THAS MATTER. THE SECRETARY OF STATE SAND THAT THE ARGENTAINES CLEARLY SAW THE AGREEMENT AS APPLYING TO THEMR ECONOMIC ZONE MINCLUDING WATERS AROUND THE FALKLANDS. SHEVARDNADZE REPLIED THAT THE RUSSMANS HAD NO MINTEREST IN COMPLEXCATION THE TER RELATIONS WHITH BRINTAMIN: HE WOULD LOOK AGAIN AT THE NUANCES OF THE AGREEMENT AND GIVE A MORE DETANLED ANSWER LATER.
